**Highway Works on A3124, Torrington**

There is a length of embankment/drystone retaining wall just east of RHS Rosemoor Gardens which is showing signs of deterioration and has caused cracking in the carriageway. The section of cracking also has no support in the form of a retaining wall, which is also the reason for this scheme.

It has been concluded that a road closure is required for this work, to safeguard both the contractor and members of the public, however when traffic lights are able to be deployed they will replace the road closure.

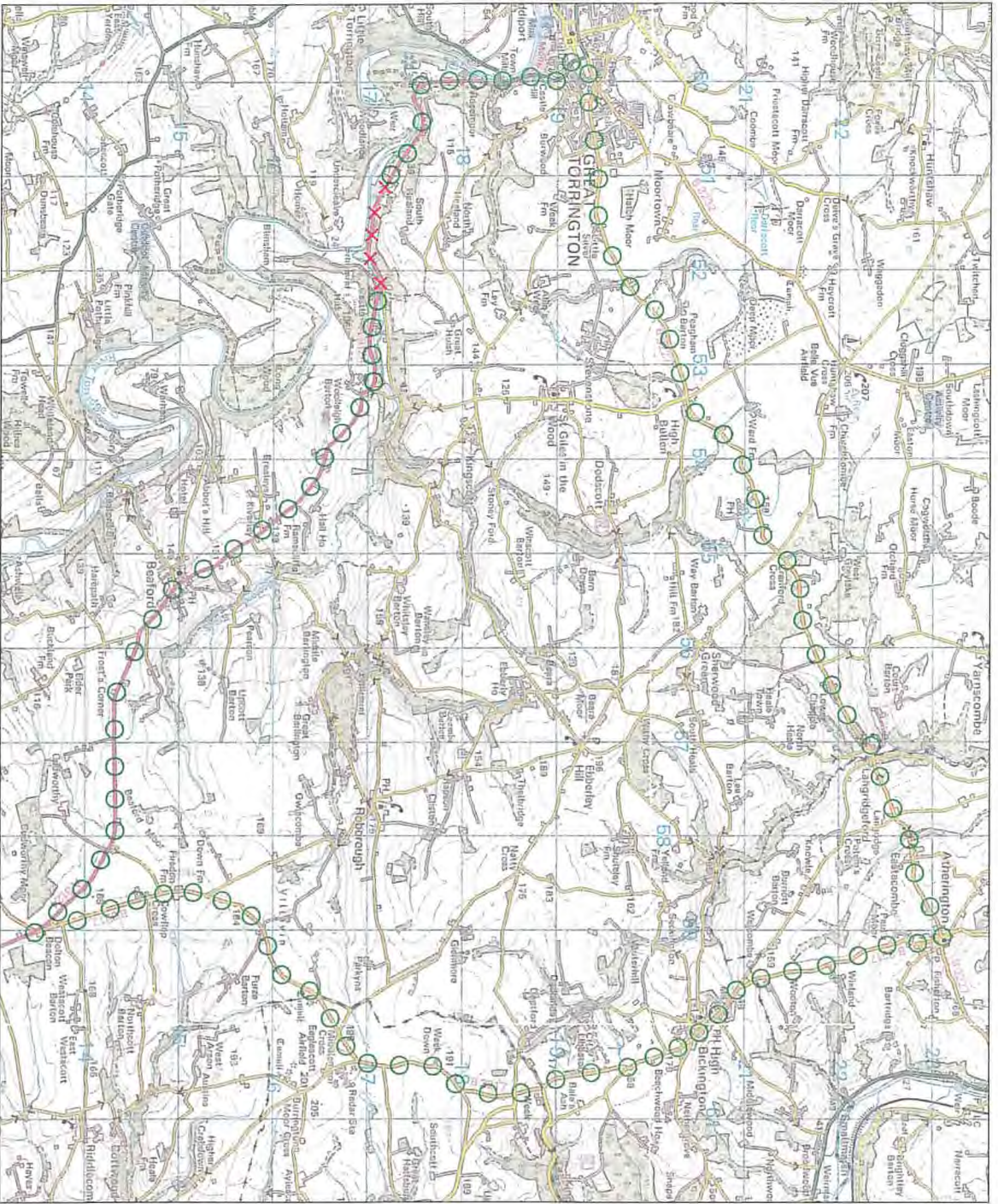
The road closure is anticipated to be in operation from 10/09/18 until 30/11/18, 24hrs a day, but we are hoping that this duration will be reduced.

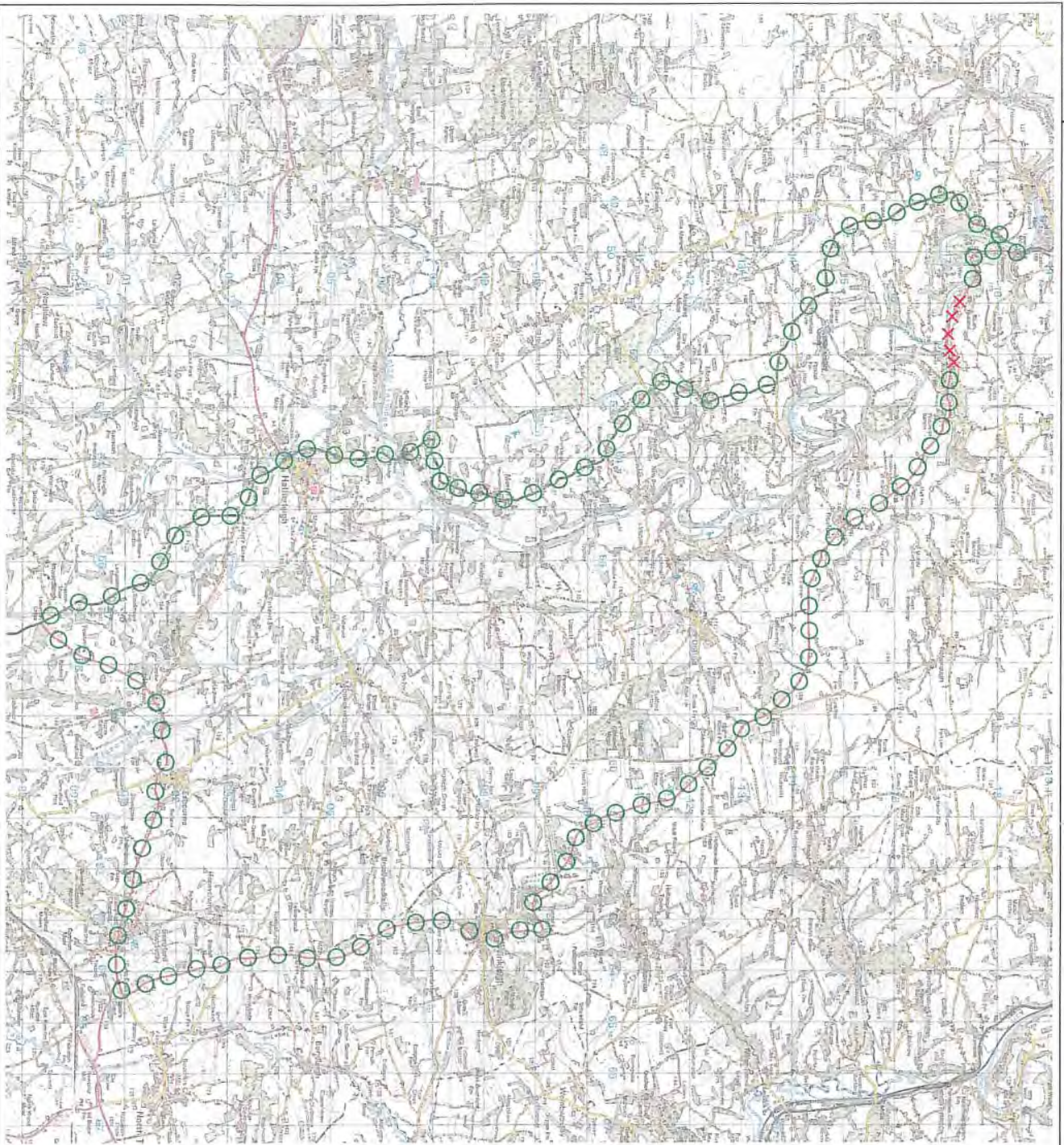
